## **GUIDELINES ON SIGNBOARD @ BUSINESS PREMISES**

### **REGULATIONS - DBKK**

---

#### **SIGNBOARD, BILLBOARD AND BANNERS**

Before a company/shop mount their signboard, they are required to use the National Language to indicate their company's name or other form of name but it must be spelt correctly (preferably proof-read by Dewan Bahasa Dan Pustaka).

If the wordings are correct then they may proceed to apply for a signboard license. They can only mount their signboard after obtaining approval.

Photographic evidence need to be submitted together with the application form.

There are 2 rates levied for signboard - Illuminated and non-illuminated, and their rates are varied.

The rates are as follows:

#### **ILLUMINATED SIGNBOARD**

1 sq meter - RM75.00

1.1 sq meters - RM82.50

Rate increment of RM7.50 per 0.1 sq meter

#### **NON-ILLUMINATED SIGNBOARD**

1 to 2 sq meters - RM75.00

2.1 sq meters - RM80.00

Rate increment of RM5.00 per 0.1 sq meter

A company/shop is only allowed a free signboard not exceeding 2 square meters but must be mounted at the top and in front of the entrance.

Painted signboard (normally on walls) is considered as signboard too and the rate levied is based on the size of the letterings.

## **BILLBOARD**

1 sq meter - RM125.00 annually

## **BANNER**

1 sq meter - RM125/365 days (daily rate)

## **Notes**

*The exclusive use of Bahasa Malaysia was made mandatory in the early 1970. However, DBKK does not enforce this rule.*

## **REGULATIONS – PENAMPANG DISTRICT COUNCIL**

---

### **NON-ILLUMINATED SIGNBOARD**

1 sq ft - RM6.00

### **ILLUMINATED SIGNBOARD**

1 sq ft - RM6.00 x 25% (1 time payment only)

### **WALL SIGNBOARD (PAINTED)**

Adopt rate as per Non-illuminated

## **BILLBOARD**

1 sq ft - RM6.00 annually

## **BANNER**

1 sq ft - Rm0.055 x days (daily rate)
